**Postdoctoral PNP/CAPES 2019 Fellowship Selection - PPG-CiAC**

The Graduate Program in Environmental Sciences and Conservation of the Federal University of Rio de Janeiro (PPG-CiAC/UFRJ) will select one candidate for a Postdoctoral Fellowship of the National Postdoctoral Program (PNPD/CAPES) according to the following terms:

**I. Application Period:** 10/04/2019 a 26/04/2019

**II. Candidates:** Candidates must hold a PhD title when the Fellowship is implemented (end of April 2019), obtained in Graduate courses recommended by CAPES and recognized by the CNE/MEC-Brazil. In cases of PhD Titles or equivalent obtained in foreign institutions, acceptance of Diplomas or Certificates will be evaluated at the moment of application. All other requirements and attributions of the candidates must conform to the norms of CAPES Ordinance 86, of July 03, 2013.

**III. Application and Required Documents:** Applications will be received exclusively by e-mail. The following documents should be sent to [ppgciac@nupem.ufrj.br](mailto:ppgciac@nupem.ufrj.br) and to [didario@gmail.com](mailto:didario@gmail.com):

1. Application form, according to the model available at the end of this document.
2. Copy of the PhD Diploma issued by an official institution, national (Brazil) or foreign, or official document of the institution attesting the PhD Title, according to item II.
3. *Curriculum vitae* (CV) in .pdf, in the CNPq “complete *lattes* format” (<http://lattes.cnpq.br>) or equivalent in the case of foreign (non-Brazilian) candidates.
4. Simplified Memorial emphasizing major activities developed during the candidate’s career, and future perspectives in research, teaching and outreach in the context of PPG-CiAC.
5. Research Project (minimum 5 pages, in Portuguese or English) to be developed in the context of PPG-CiAC, emphasizing the candidate’s insertion in scientific activities in one or more Research Lines conducted in the Program.
6. Letter of Recommendation signed by an accredited professor at PPG-CiAC, who will co-supervise the activities of the Fellowship holder together with the Program Coordinator.
7. Other documents relevant to the evaluation of the application (optional)

**IV. About the Selection Process:** The Selection Process will be conducted by a Selection Committee appointed by the Deliberative Committee of PPG-CiAC. The following items will be evaluated during the Selection:

1. CV: previous experience and educational training of the candidate. A grade of 6.0 or higher in the Analysis of CV should be obtained.
2. Memorial: experience in scientific research, as well as planned actions in PPG-CiAC, including:
  - a) information that demonstrates the potential or actual insertion of the candidate in one or more research groups in PPG-CiAC;
  - b) perspectives of generation of written scientific products (papers/books, etc) in partnership with teachers and students of the Program. A grade of 6.0 or higher in the Analysis of the Memorial should be obtained.



3. The Research Project will be analyzed with emphasis on the feasibility of the proposed plan, its scientific merits, and its insertion in one or more research lines currently developed by professors accredited in the PPG-CiAC, to which the Postdoctoral Fellow will be directly associated. The scientific innovation that the project intends to generate and its potential for publication and dissemination will also be analyzed. A grade of 6.0 or higher must be obtained in the Analysis of the Research Project and Letter of Recommendation.

**V. Classification:** Candidates that achieve the minimum grades in the Analyses of the CV, Memorial and Research Project/Letter of Recommendation during the Selection Process will be considered eligible for the PNPd Fellowship, respecting the classification order and the following terms:

1. Only one PNPd/CAPES Postdoctoral Fellowship is currently available. The candidate indicated as first in the ranking will be selected, and its enrolment in the PNPd Program as a Post-Doc should be implemented immediately after Results of the Selection are announced.
2. In the event of withdrawal of the candidature or inability to receive the Fellowship immediately for any reason, other candidates will be contacted in the order of classification for a period of up to three months after the announcement of the Results.

**VI. Announcement of Results:** Results of the Selection Process will be posted in the board of messages available at the Office of PPG-CiAC, in NUPEM/UFRJ, and will also be announced by e-mail and at the Program website (<http://ppgciac.macaue.ufrj.br>) after May 2<sup>nd</sup>, 2019. **VII. Appeals of Results:** Appeals will be received within one business day after the results are announced. Appeals must be presented by the candidate in a justified letter signed exclusively by the candidate, delivered to the Office of PPG-CiAC in NUPEM/UFRJ or sent to [ppgciac@nupem.ufrj.br](mailto:ppgciac@nupem.ufrj.br) and [didario@gmail.com](mailto:didario@gmail.com).

**VIII. Duration of the Fellowship:** The PNPd Fellowship will be granted for twelve months, and may be renewed annually by submitting a Scientific and Activity Report that demonstrates scientific/intellectual production of relevance to PPG-CiAC, for a maximum period of five years.
